- 2. The submitter receiving the award will obtain or possess the following insurance coverages and will provide Certificates of Insurance to CLH to verify such coverage.
 - A. Workers' Compensation The vendor shall provide coverage for its employees with statutory workers' compensation limits, and no less than \$500,000.00 (each occurrence) for Employers' Liability. Said coverage shall include a waiver of subrogation in favor of CLH and its agents, employees and officials.

Business Automobile Liability - The vendor shall provide coverage for all owned, non-owned and hired vehicles with limits of not less than \$1,000,000.00, per occurrence, Combined Single Limits (CSL) or its equivalent.

- B. Professional Liability (Errors & Omissions) The vendor shall provide coverage for all claims arising out of the services performed with limits not less than \$1,000,000.00 per claim. The aggregate limit shall either apply separately to this contract or shall be at least twice the required per claim limit.
- C. The architect/engineering firm awarded this contract shall maintain adequate records to justify all charges, expenses, and costs incurred in estimating and performing the work for at least three (3) years after completion of any project work performed under contract resulting from this RFQ. CLH shall have access to all records, documents and information collected and/or maintained by others in the course of the administration of the agreement. This information shall be made accessible at the awardees place of business to CLH, including the Comptroller's Office and/or its designees, for purposes of inspection, reproduction and audit without restriction.
- D. It is the intent of CLH to enter into a contract to provide architectural, engineering and consulting services as described herein.
- 3. There shall be no contact between submitters and CLH Administration and/or Board members after the close date and time. Such contact may be grounds for disqualification.

- Qualifications of staff to be utilized on this project with names, short resumes, length of time with firm and previous clients served. Experience must be with submitting firm.
- Names of at least 3 previous Medical Facility clients within the past five ten (5 10) years with phone numbers and contact person.
 Description of previous relevant experience. Part of the experience should reference projects worked on of similar size and medically oriented.
- o Ability to provide cost models for new medical spaces.
- o This project is a Critical Access Hospital (CAH) reference CAH experience with AHCA .
- Ability and experience in working with Insurance Companies, FEMA guidelines and regulations, and the Agency for Health Care Administration (AHCA) in Florida.
- o Ability to assist and advise Calhoun-Liberty Hospital with equipment planning and selection such as CT, MRI, Radiology and X-Ray, etc.
