## INTRODUCTION

Community Health Needs Assessment (CHNA) became a requirement of all tax exempt (501(c)(3)) hospitals beginning with fiscal year 2013. As part of the IRS Form 990, Schedule H, individually licensed not-for-profit hospitals are required to assess the health needs of their community, prioritize the health needs, and develop implementation plans for the prioritized health needs they choose to address. Reports on progress with the Implementation Plans are required to be submitted annually. Every three years, this process must be repeated.

# CALHOUN LIBERTY HOSPITAL MISSION, VISION AND VALUES

## **EXECUTIVE SUMMARY**

In 2016, Calhoun-Liberty Hospital (CLH) partnered with a steering committee of individuals representing Calhoun and Liberty Counties and developed a Community Health Needs Assessment report. Priority health needs were identified and CLH developed the Implementation Strategy Plan (ISP) to highlight the hospital's commitment to improve community health status indicators.

While the organization made progress on their 2017 – 2019 Implementation Strategy Plan (Appendix A), Hurricane Michael dramatically changed the trajectory of the hospital's efforts when it made landfall directly on Blountstown, Florida, on October 10, 2018.

The damage to CLH was significant to say the least. Due to the widespread damage in the region, resources were limited for immediate assistance to clean-up, repair and restore hospital departments in order to provide services. While it took several weeks and, in some cases, months, CLH was able to open its doors again in the midst of recovery and continues to be in a rebuilding process.

To that end, CLH participated in the 2019 – 2021 Community Health Improvement Plan with the Florida Department of Health in Calhoun/Liberty Counties to update the existing Community Health Needs Assessment and include an Implementation Strategy Plan for 2019 – 2021.

## COMMUNITY HEALTH NEEDS ASSESSMENT - RECAP

The following is a direct excerpt from the 2019 – 2021 Community Improvement Plan for Calhoun and Liberty Counites:

#### Community Health Assessment Review

In 2016, a joint initiative began between Florida Department of Health in Calhoun and Liberty Counties and Florida State University-College of Social Sciences and Public Policy to determine the health needs of the two counties. A series of assessments including, Community Themes and Strengths Assessment, Local Public Health System Assessment, Community Status Assessment, and Forces of Change Assessment were completed to determine the communities' strengths and weaknesses. Based on the communities' feedback, the following priority areas were selected as the focus for the 2018-2021 Community Health Improvement Plan (CHIP):

- Access to Care
- Mental Health/Substance Abuse
- Obesity

#### Community Themes and Strengths Assessment

The Community Themes and Strengths Assessment is comprised of identifying the issues residents of the community deem as the most important; along with distinguishing any resources available to aid in improving the health of the community. Community surveys were developed and fielded at various locations, including grocery stores, convenience stores, hospital/ER and medical clinics. In Calhoun County, 241 surveys were completed by residents (verified by zip code) between May 10-30, 2016. In Liberty County, 133 surveys were completed by residents (verified by zip code) between June 15-18, 2016.

#### Local Public Health System Assessment

The Local Public Health System Assessment (LPHSA) puts the spotlight on the network of organizations and agencies in the community and how well the ten Essential Services (ES) are being delivered. The LPHSA for Calhoun and Liberty Counties was conducted on May 24, 2017 from 9 AM to 12 PM at the Heritage Room of the Calhoun County Library. A total of 22 community partners participated in this assessment.

The community members voted the essential services (ES) #2, #3, and #5 as strong performance and ES #1, #7, #10 as needs improvement.


62.7% of the model standards fell within the *Significant Activity* category (greater than 50% but not more than 75% of the activity described within the question is met).

#### Community Health Status Assessment

The Community Health Status Assessment distinguishes and prioritizes quality of life and community health issues. The review of data was conducted during a meeting held July 24th at the Veteran's Memorial Civic Center with a total of 15 participants.

Of the 144 health indicators, Liberty County was better than the state in 60 indicators (42%), worse than the state in 83 indicators (57%), and the same as the state in one indicator (1%).

Calhoun County performed better than the state in 55 indicators (39%), worse than the state in 87 indicators (60%), and the same as the state in two indicators (1%).

#### Overview

The DOH Calhoun/Liberty CHIP was developed in collaboration with local community members who have a goal of achieving improvements in each of the priority areas. Prior to the development of this CHIP, two community member meetings were held at the Veteran's Memorial Civic Center; meetings were held on April 16th and May 23rd of 2017. The CHIP committee was composed of a variety of representatives and community members. Attendees were encouraged to represent their organizations, state their concerns, and offer insight on how to address and improve the priority areas. Outlined in this document are the proposed work plans and their intended implementation.

#### Review of Key Data

Areas with the need for improvement/aid and shortcomings were selected, listed for each priority is the analyzed data best representing the strengths and shortcomings of both communities. This data has been extracted from the Community Themes and Strengths Assessment, Local Public Health System Assessment, Community Status Assessment, Forces of Change assessments, and Florida CHARTS. #### Developing Priority Area Action Plans

Attendees collaborated to discuss and develop action plans for each of the priority areas. The action plans identify the goal, objective, strategies, work plan, and community partners for each priority area. For the remainder of this project these terms will be defined as:

- Goals: The 3-5 year plan the community wishes to achieve.
- Objectives: Specific, measurable, achievable, relevant, time bound plans to obtain goals.
- Strategies: The steps needed to achieve the objectives.
- Work plan: Describes timeline and how strategies will be achieved
- Community Partners/Partner Agencies: Community members working to achieve and sustain goals.

#### Binder Overview

Through committee discussions it became apparent community members and providers are unaware of resources available. Committee members commissioned the organization to create a "Resource Binder". The binder contains information pertinent to each priority area, it will be disseminated to local organizations such as churches, schools, and healthcare providers.

## **SERVICE AREA**

The service area for CLH is defined at Calhoun County, FL, and Liberty County, Florida. In an analysis of inpatient origin by ZIP Code, the service area was defined to include 7 primary ZIP Codes across Calhoun and Liberty Counties, where 89% of CLH's inpatients reside.


#### Service Area Demographics

Based on the most recent available U.S. Census data (2019), the population of Calhoun County, Florida, is 14,982, and the population of Liberty County, Florida, is 9,167, for a total service area population of 24,149. The CLH service area has a slightly larger cohort of individuals age 65+ (16.7%) compared to the U.S. population of age 65+ of 15%.

Median income for both counties is about \$38,300. Calhoun County's percentage of the population below 100% of poverty is 14.7% compared to Liberty County's 16.8% of the population below 100% poverty.

The program collects health data annually to bring awareness to the factors that influence health and strategies for improving the health of communities.

The County Health Rankings define Premature Death as leading causes of death for those under the age of 75 within the categories of malignant neoplasms, diseases of the heart, accidents (unintentional injuries), chronic lower respiratory diseases and intentional self-harm (suicide). This data is age-adjusted to ensure it is comparable across counties.

The rate of premature deaths in Calhoun County is significantly higher compared to Liberty County and the State. Calhoun County ranks 58 of 67 counties in Florida in terms of "healthiest," or least healthy with higher rates of smoking, obesity and sexually transmitted diseases.

Clinical Care measures were also reviewed for the service area counties.

Based on these measures, there is significant opportunity to increase the availability of primary care services in Calhoun and Liberty Counties to drive preventative screenings and provide a gateway to managing mental health needs.

#### **MORTALITY RATES**

Mortality rates from the National Center for Health Statistics indicates the service area population has an overall higher mortality rate as compared to the State of Florida. For both Calhoun and Liberty Counties, the mortality rate for chronic lower respiratory disease is significantly higher compared to the State of Florida.

#### **CANCER INCIDENCE RATES**

In reviewing cancer incidence data in the service area compare to the State of Florida, lung cancer rates are higher in Calhoun and Liberty Counties as compared to the State incidence rate and the rate of skin cancer (melanoma) is almost 70% greater than the State rate. Breast cancer rates in Liberty County are much higher than in Calhoun County and comparable to the State rate.

Liberty County has a higher rate of 18–24-year-olds without a high school diploma compared to Calhoun County and the Non-Metro State rates. According to the Rural Health Information Hub, 100% of Liberty County residents have personal income less than \$100K.

83.4% of Calhoun County residents do not have access to healthy food, as measured by residents' proximity to the nearest supermarket (more than 10 miles).

## PRIORITIZATION OF HEALTH NEEDS

In consideration of the quantitative as well as qualitative feedback, the following community health needs were identified and prioritized:

- Access to health care
- Obesity
- Mental health/substance abuse

# APPENDIX A - 2017-2019 CHNA IMPLEMENTATION PLAN

#### **Community Health Assessment Review**

In 2016, Calhoun-Liberty Hospital collaborated with the Florida State University College of Social Sciences and Public Policy, Demography Department and Public Health Program to study Calhoun and Liberty Counties' health needs.
